


HIGH RISK EROSION AREA (shading alongshore)

THESE AREAS ARE LEGALLY DEFINED BY THE SHORELANDS PROTECTION AND MANAGEMENT ACT, 1970 P.A. 245, AS AMENDED, AS BEING GREAT LAKES SHORELAND AREAS DOCUMENTED TO REcede AN AVERAGE OF ONE FOOT OR MORE PER YEAR.


