Leadership So Everyone Goes Home is a four-hour program designed to assist the chief level officer to define the tools to identify:

1. Issues that could lead to a line of duty death or serious injury,
2. How the death/injury occurred,
3. How it could have been prevented,
4. What steps should a fire department take to reduce the possibility of experiencing this action and outcome.

This program is specifically designed for the more senior level fire officers who have had opportunities to be command officers at a wide variety of emergency incidents, including fires and hazardous materials responses. Utilizing case studies, the learning objectives become more real to life and the possibility of changing the organizational culture to reduce the possibility of deaths and injuries in the future.

Course Hours: 4

Attributes of Leading (G16A) (New 6/8/2021)

Attributes of Leading is a highly interactive, practical, case study-based course. The format is 6 hours in length and best delivered to audiences of no more than 12 attendees. The program focuses on six qualities of leading: Competence, Constructive Influence, Grit, Humility, Presence, Resilience, Self-Mastery, Self-Regulation, Stepping Up, Trust, Vigilance, and Being Well. Attributes of Leading is designed to build more effective fire service leaders of all ranks. Through a process of view, review, introspection, and discussion, the program seeks to stimulate leaders to focus on qualities that constructively influence members regarding overall performance, health and safety. Short videos for each attribute featuring firefighters and officers from across the country, as well as thoughtful words from the late Chief Alan Brunacini and other fire service leaders are used to stimulate discussion. The direct delivery version takes attendees through six of the twelve attributes.

NFPA 1041 Instructor II (H08B) (updated 12/17/2021)

This NFPA 1041 Fire Instructor II course was released on December 17, 2021. This NFPA 1041 Fire Instructor II course minimally meets all objectives and JPRs in the 2019 edition of NFPA 1041. The textbook used for the current NFPA 1041 Fire Instructor I course is the Jones & Bartlett *Fire and Emergency Services Instructor 3rd Edition* and instructors, and students will use the J&B Navigate online learning platform during the seven (7) session course. The course consists of five (5) in person or virtual sessions and two (2) in person sessions. The written exam will be held on the first in person session and the practical will be held on the second in person session. Student preparation and homework completion is required prior to the online session of class. This course requires two instructors who are certified by the FFTD to teach the course. The instructor must attend a Train the Trainer to be authorized to teach this course. The course is limited to 16 students per course.

Training Operations in Small Departments (H14A)

I Series Courses: Manager & Supervisor Development

Intermediate ICS for Expanding Incidents ICS-300 (I15B) (updated March 2020)

This course is designed for those emergency response personnel who would function in a Command or General Staff position during a large, complex incident or event. Or those personnel who are or would likely be part of a local or regional Incident Management Team during a major incident, whether single agency, multiagency or Unified Command.

Course Hours: 24

Instructor Fee: \$2,640.00 using 2 instructors.

Advanced ICS Command and General Staff - Complex Incidents ICS-400 (I16B) (updated March 2020)

This course is designed for those emergency response personnel who would function as part of an Area Command, Emergency Operations Center, or Multiagency Coordination System during a large, complex incident or event. Or those personnel who are or would likely be part of a local or regional Incident Management Team during a major incident, whether single agency, multiagency or Unified Command.

Course Hours: 16

Instructor Fee: \$1,760.00 using 2 instructors.

Shaping the Future (I20A)

This two-day course is designed to assist first- and second-level supervisors and Company Officers (COs) in developing knowledge and skills in contemporary approaches to organizational problem-solving. Topics include use of creative approaches to identifying trends within their organizations; applying problem-solving methodologies; the importance and application of continuous improvement within organizations; how to quantify problems and solutions; factors in organizational and individual resistance to change; and strategies for implementing change. The course incorporates facilitated, student-centered methodologies, including lecture, small and large group activities, and individual assessments.

Leadership in Supervision: Creating Environments for Professional Growth (I30A) (approved 10-27-2017)

This two-day course presents the supervisory with the basic leadership skills and tools needed to perform effectively in the fire service environment. The course includes concepts related to a successful transition to supervisory and leadership roles, including concepts of adaptive leadership; change management; active followership; effective communication, including difficult conversations and advocacy-inquiry based dialogue; ethics; authority; power; decision-making; and active engagement through development of a personal plan.

Leadership in Supervision: Perspectives in Thinking (I31A) (approved 10-27-2017)

The course addresses skills needed for assessing situations from multiple perspectives, making critical decisions, fostering creativity and innovation, and using persuasion.

Leadership in Supervision: Frameworks to Success (I32A) (approved 10-27-2017)

This two-day course provides the supervisor with the knowledge and skills to perform successfully in the fire and Emergency Medical Services environments. The course addresses professionalism, resilience, emotional intelligence, and situational awareness, as well as managing conflict, delegating mentoring, coaching, empowering, and building collaboration and synergy for professional growth.

K Series Courses: Rescue

Vehicle Extrication (K01B)

This course is designed to provide Fire Fighters with a better understanding of the current techniques available for the swift extrication of victims from a variety of vehicle entrapments.

This course is designed to provide Fire Fighters with a better understanding of the current techniques available for the swift extrication of victims from a variety of vehicle entrapments.

Agriculture Machine Rescue (K05A)

Agriculture is one of the most dangerous industries in America. Each year, needless injuries and deaths occur to farmers, family members, farm employees, and rescue personnel. Emergency responders often lack knowledge of the nature of farm machinery, chemicals, and farm structures; in addition, some rescue techniques may actually increase the risk to the victim and rescue personnel. Training and education in the methods of farm/rural rescue are essential for proper response and safety of the rescuer and patient. The main goal of the **National Farmedic Training Program** developed by Cornell University is to provide rural fire/rescue responders with a systematic approach to farm rescue procedures that address the safety of both patients and responders. Attending the McNeil & Associates Farm Medic Train the Trainer is required to be able to teach this class.

Course Hours: 16

Instructor Fee: \$1,760.00 using 2 instructors

Elevator Training (K10B)

The intent of this course is to provide Fire Fighters with information on how elevators are constructed, and operate, how to use an elevator key to unlock entry door, who to contact in case of an elevator emergency, and safety tips.

Course Hours: 8

Instructor Fee: \$1100.00

Confined Space Rescue (K15A)

This 24 hour program meets the NFPA 1670 requirements for members of an organization providing confined space rescue at an awareness and operations level. The program meets and exceeds the knowledge, skills, and abilities requirements of the NFPA 1006 Level 1 Technical Rescuer (Confined Space Rescue) section.

Course Content:

Awareness Level

- Recognize the need for confined space search and rescue.
- Initiate contact and establish communications with victims where possible.
- Recognize and identify the hazards associated with non-entry confined space emergencies.
- Recognize confined space.
- Perform a non-entry retrieval.
- Implement the emergency response system for confined space emergencies.
- Implement site control and scene management.
- Operations Level (Confined Space Rescue Level 1).
- Conduct monitoring of the environment.
- Prepare for entry into the confined space.
- Enter a confined space.
- Package the victim for removal from a confined space.
- Remove all entrants from a confined space.

Course Hours: 32

Instructor Fee: \$1,760.00

Rope Rescue Operations (K16A)

This 40-hour program exceeds the capabilities required in NFPA 1670 for an Operations level team.

This is a hands-on, practical course specifically designed to address the needs of fire and rescue agencies which may be called upon to perform rope based rescues from above or below grade including the rescue of workers suspended on fall arrest as well as in support of operations at confined space, trench and structural collapse rescue incidents.

While the emphasis is on working as a team to complete the rescues, there are numerous individual skills are critical to that success. Throughout the program there is a strong emphasis on basic skills and safety. These fundamentals are important, not just for class, but as a foundation for all future rope rescue training. Each of the techniques presented has been tested and proven; and some will be proven again as a part of the program, especially in the belay workshop. After successfully completing the course, participants are able to work safely at rope rescue incidents, operate the commonly used systems (lower, raise and belay) and be familiar with the techniques used for the typical rope rescue incidents.

Course Hours: 40

Instructor Fee: \$2,200.00

Trench Rescue Awareness and Operations (K17A)

This 24-hour program meets the NFPA 1670 requirements for members of an organization providing trench rescue at an awareness and operations level. The program meets and exceeds the knowledge, skills, and abilities requirements of the NFPA 1006 Level 1 Technical Rescuer (Trench Rescue) section.

Course Content:

Awareness Level

- Recognize the need for a trench and excavation rescue.
- Identify the resources necessary to conduct safe and effective trench and excavation emergency operations.
- Initiate the emergency response system for trenches and excavations.
- Initiating site control and scene management.
- Recognize general hazards associated with trench and excavation emergency incidents and the procedures necessary to mitigate these hazards within the general rescue area and recognizing the unique hazards associated with the weight of soil and its associated entrapping characteristics.
- Recognize typical trench and excavation collapse patterns, the reasons trenches and excavations collapse, and the potential for secondary collapse.
- Initiate a rapid, non-entry extrication of non-injured or minimally injured victim(s).
- Operations Level (Trench Rescue Level 1).
- Conduct a size-up of a collapsed trench.
- Implement a trench emergency action plan.
- Implement support operations at trench emergencies.
- Support a non-intersecting straight wall trench of 8 ft or less.
- Release a victim from soil entrapment by components of a nonintersecting collapsed trench of 2.4 m (8 ft) or less in depth.
- Remove a victim from a trench.
- Disassemble support systems (sheeting/shoring) at a trench emergency incident.

Course Hours: 24

Instructor Fee: \$1,320.00

Trench Rescue Technician (K18A)

The course includes eight hours of intense didactics (classroom). Designing trench rescue shoring systems is an art that must be based on science. The problem is that most rescuers and most “so called” rescue instructors do not understand the basic science that is involved. Knowing how to calculate the potential soil forces and shoring system strength is paramount to both victim and rescuer safety. Many rescue shoring systems being taught today have been designed without scientific data. In most cases rescuers are left to rely on luck and memory of rote system learning.

The MUSAR Training Foundation’s Trench rescue technician course teaches the participants to apply critical thinking and system analysis skills to design and install rescue shoring systems in trenches and excavations. Students will participate in shoring system testing that will take walers, panels and strong-backs to failure. This destructive testing will provide a new level of understanding of trench shoring and will aid the technicians in developing and installing systems that provide calculated safety margins.

Structural Collapse Rescue Technician (K19A)

This program meets the objectives of the National Fire Protection Association (NFPA 1670 and 1006). MUSAR Collapse Rescue training programs are being used in all of the state regions that have been mandated, by the Michigan Department of Homeland Security, to develop urban search and rescue capabilities. The use of MUSAR collapse programs provides standardized response capabilities throughout the three largest urban areas in our state. Those regions are Region One (Lansing area), Region Two (Detroit area) and Region Six (Grand Rapids area).

Based on a response system of local, mutual aid, regional and state assets that are commonly used in Michigan, the collapse rescue team duties and techniques taught in this class are recognized and widely accepted as the “best practices” across the state. This allows rescuers from inter-county, regional and state response systems to work safely and efficiently at collapse rescue incidents.

The “pneumatic shoring recovery” plan was developed from Michigan-specific structural collapse incidents (tornado in Springfield Township, explosion in Flint, explosion in Wayne). These methods and techniques taught in the Technician course have become the standard for collapse rescue teams throughout the state.

The MUSAR Training Foundation continues to work closely with MI-OSHA to provide training on updated procedures for safety concerns that are found at rescue scenes throughout the state of Michigan. Since Michigan is not a Federal OSHA state many of these “Michigan Specific” methods are not found in any other collapse rescue training curriculum.

L Series Courses: Suppression

Firefighting Strategies and Tactics (L04B)

This course begins with a history of firefighting and the reasons that it has evolved throughout the years. It is followed by background information necessary to make effective fire ground decisions. The next two chapters include information on fire dynamics and extinguishing agents. The next six chapters deal with concepts common to all incidents including incident management systems, command and control considerations, firefighter safety, company operations, built-in fire protection, and considerations for after the incident. The second half of the course provides the reader with information necessary to apply the common concepts for specific occupancies to include, one-and two-family dwellings, multifamily dwellings, commercial occupancies, places of assembly, high-rise structures, vehicle fires, wildfires, and basic information for special fires. The final chapter allows the reader to apply the concepts to written scenarios.

This course is equivalent to the Managing Company Tactical Operations-Preparing/Decision/Strategies and Tactics for Initial Company Operations series (MCTO-P, MCTO-T and STICO) and can be used as a prerequisite for the Company Officer.

Preparation for Initial Company Operations (L05B)

PICO is designed to provide a basic foundation for the management of one or more companies operating at a structural fire emergency. Key content includes Roles and Responsibilities, Readiness, Communication, Building Construction and Fire Behavior factors, and Pre-incident Preparation.

Decision Making for Initial Company Operations (L06B)

This two-day course is designed to develop the decision-making skills needed by Company Officers (COs) to accomplish assigned tactics at structure fires. All activities and scenarios used in this course are based on structure fires. With the real possibility of being the first to arrive at an incident, the CO's initial decisions will have an impact throughout the entire incident. It is vital that COs be able to make good management decisions that have a favorable impact on the eventual outcome. In addition to a possible role as the initial Incident Commander, the CO may well be assigned a subordinate position within the Incident Command System organization. COs need to have a clear understanding of the system, the position that they are assigned to, and their role in the organization if they are to function effectively and help make the system work.

Strategy and Tactics for Initial Company Operations (L08A)

This course is designed to meet the needs of Company Officers responsible for managing the operations of one or more companies during structural firefighting operations. STICO is designed to develop the management skills needed by company officers to accomplish assigned tactics at structure fires.

Chimney Fire Suppression (L10A)

This course was designed to give Fire Fighters information on the history of wood burning, chimney construction, and woodstove clearances. It also includes a discussion on fuels, a segment on the use of wood burning stoves, and suppression techniques for use on chimney fires.

Incident Command System and Resource Management for the Fire Service (L13B)

This two-day program provides students with an understanding of the Incident Command System (ICS) and resource management for the fire service and their application in both emergency and nonemergency situations. - Command and control issues of WUI firefighting.

Assessing Wildfire Hazards in the Home Ignition Zone (L31A)

Wildland fire is a threat in virtually every part of the United States. NFPA's 2-day Home Ignition Zone workshop is designed to (1) provide reference material and basic knowledge, (2) increase an understanding and competency in wildland/urban interface fire mitigation, (3) assist wildfire mitigation and prevention professionals, regardless of organizational affiliation, in assessing risks to individual homes in wildland, forested, or grassland areas, and (4) encourage and prepare residents and homeowner associations to participate in Firewise Communities/USA® Recognition Program.

Wildland Crew Boss (Single Resource) S-230 (L32A)

This is a classroom course designed to produce student proficiency in the performance of duties associated with the single resource boss position from initial dispatch through demobilization to the home unit. Topics include operational leadership, preparation and mobilization, assignment preparation, risk management, entrapment avoidance, safety and tactics, offline duties, demobilization, and post incident responsibilities.

This course is presented by Michigan DNR and/or USFS Forest Fire Officer instructors.

- Describe crew boss responsibilities prior to and during mobilization, on the incident, and during demobilization.
- Identify the hazards and risks on various incidents and describe how to mitigate them.
- Describe tactics which are appropriate to various wildland fire situations and procedures to implement them through the chain of command.

Wildland Engine Boss (Single Resource) S-231 (L33A)

This is a skill course designed to produce student proficiency in the performance of the duties associated with engine boss, single resource (ENGB). Topics include engine and crew capabilities and limitations, information sources, fire sizeup considerations, tactics, and wildland/urban interface.

This course is presented by Michigan DNR and/or USFS Forest Fire Officer instructors.

- Perform the tasks of an engine boss in making the tactical decisions required to safely manage an engine on an incident.

Intermediate Wildland Fire Behavior S-290 (L34A)

This is a classroom-based skills course designed to prepare the prospective fire line supervisor to undertake safe and effective fire management operations. It is the second course in a series that collectively serves to develop fire behavior prediction knowledge and skills. Fire environment differences are discussed as necessary; instructor should stress local conditions.

This course is presented by Michigan DNR and/or USFS Forest Fire Officer instructors.

Course Objectives:

- Identify and describe the characteristics of fuels, weather, and topography that influence wildland fire behavior.
- Describe the interaction of fuels, weather, and topography on wildland fire behavior, fire line tactics, and safety.
- Describe the causes of extreme fire behavior conditions (long range spotting, crowning, and fire whirls) that develop due to weather, fuels, and/or topography.
- Interpret, communicate, apply, and document wildland fire behavior and weather information.

Task Force / Strike Team Leader S-330 (L35A)

This course is designed to meet the training requirements outlined in the PMS 310-1, Wildland Fire Qualification System Guide and the position task books developed for the positions of task force leader and strike team leader. Most examples and exercises in this package are specific to wildland fire suppression, although some all-hazards exercises are included.

This course is presented by Michigan DNR and/or USFS Forest Fire Officer instructors.

Course Objectives:

- Demonstrate the ability to apply the Risk Management Process found in the Incident Response Pocket Guide (IRPG) to various incidents.
- Identify and describe the responsibilities of a Task Force/Strike Team Leader (TFLD/STL).
- Demonstrate the ability to apply appropriate tactics with assigned resources organized into strike teams or task forces.

Tactical Decision Making in Wildland Fire S-336 (L36A)

This course is designed to meet training requirements in the Operations Section of the Incident Command System. Examples and exercises in this package are specific to wildland fire suppression.

- Develop the knowledge and practice in decision making necessary to effectively apply wildland fire suppression tactics.
- Develop the tools for leadership in applying and teaching appropriate fire suppression tactics at their home unit.

Initial Attack Incident Commander S-200 (L37A) (New 4/13/2021)

This course is designed to meet the training needs of the incident commander type 4 (ICT4). It is presented in a discussion/exercise format. The six instructional units include Foundation Skills; Intelligence Gathering and Documentation; Size Up the Incident; Develop a Plan of Action; Post-fire Activities; Evaluating Incident Objectives and Manage the Incident. Evaluation of the student is by unit tests and performance-based evaluations.

- Demonstrate effective foundation skills (leadership, risk management, and communications) at the ICT4 level.
- Gather and document essential information about the incident.
- Size up the incident, develop plan of action.
- Manage the incident through effective leadership.
- Demonstrate the ability to evaluate plan of action and make adjustments to the plan when necessary.
- Conduct post-fire activities.

Wildland Fire Observations and Origin Scene Protection for First Responders FI-110 (L38A) (New 4/13/2021)

The primary emphasis of this course is to teach sound wildland fire observations and origin scene protection practices that enable first responders to a wildland fire scene to perform proper origin scene protection procedures. The course is presented by short lectures, electronic presentations, exercises, and class discussion.

- List various causes of wildland fires and their cause indicators.
- Perform the basic procedures and techniques needed to provide witness/observer information to fire investigators.
- Identify and protect wildland fire origin areas.
